## Drag on Bottom-line driven by Distribution Cost Pressures

#### WHAT WE LIKE ABOUT THE RESULT

- 1. Revenue from the Food business segment contributed 59.0% to total Revenue and it increased by 17.6% to №101.1 billion in H1-2021.
- 2. Total Revenue grew by 21.6% y/y for H1-2021. Also, a quarterly analysis showed that Revenue notched 19.1% y/y to №84.2 billion.
- 3. Administrative Expenses moderated mildly by 5.9% y/y to №3.3 billion from №3.5 billion.
- 4. 28.0% decline in Trade and Other Receivables showing quality Revenue generating techniques.
- 5. Higher Cashflow from Operations compared to same period last year. Cashflow from Operations increased by 92.6% to №50.7 billion from №26.3 billion.

#### WHAT WE DID NOT LIKE ABOUT THE RESULT

- 1. The decline in Gross Profit Margin despite the 8.6% y/y increase in Gross Profit to ₹31.7 billion.
- 2. 39.2% increase in Marketing and Distribution Expenses reflecting the company's adjustment to tougher operating environment. The ripple effect was a 4.6% decline in Operating Profit to №16.0 billion from №16.8 billion.
- 3. A significant increase in Finance Costs (by 277.3%) due to additional Loans and Borrowings made during the period.
- 4. Interest Expense on Financial Liabilities surged by 258.4% y/y to №3.4 billion in H1-2021 from №937.4 million.
- 5. 12.2% decline in Profit After Tax (PAT). However, PAT figures would have been lower compared to Q2-2020, if there was no decline in Income Tax Expense.


